**Item No. 1.1**

**Confirmation of the minutes of the last meeting held on 23<sup>rd</sup> February, 2010**

The minutes of the last meeting were read out and confirmed.

**Item No.1.2**

**Visit of Distance Education Council Team to accord approval to the programmes through distance mode**

The members were informed that a Team from Distance Education Council (DEC), IGNOU, New Delhi visited the university on 22<sup>nd</sup> April, 2010 to assess the physical infrastructural facilities and the academic pattern to be offered to undergraduate and post graduate levels through distance mode. The visit was conducted satisfactorily.

**Item No.1.3**

**Visit of Team from the Council of Architecture to accord extension to B Arch Degree programme**

The members were informed that based on the recommendations of the Visiting Team which visited the University on 24<sup>th</sup> and 25<sup>th</sup> February, 2010, the Council of Architecture has extended the approval to the existing five year B. Arch degree programme with an additional intake of

40 for three years from the academic session 2010-11 to 2012-13 vide its letter dated 12<sup>th</sup> April, 2010. The efforts were applauded by all the members.

**Item No. 1.4**

**Participation in AIEEE 2010.**

The members were informed that efforts are being made to participate in AIEEE 2010 for admission to B Tech degree programmes from academic session 2010 onwards. A sum of Rupees ten Lakhs has been paid to 'Central Counseling Board 2010' towards fee for the same. The efforts were applauded by all the members. Final approval from the Central Counseling Board – 2010 is awaited.

**Item No. 1.5**

**To obtain the merit list of 'Common Law Admission Test (CLAT)' for admission to Five year integrated BA LLB course.**

The members were informed that the efforts are being made to obtain the Merit List of 'COMMON LAW ADMISSION TEST (CLAT)' – 2010 for admissions to five year integrated BA LLB course to maintain the best academic standard. It was mentioned that National Law Institute University, Bhopal which is conducting CLAT 2010 has agreed to provide us the data in this regard, on payment of specified fees. The efforts were applauded by all the members.

**Item No.1.6**

**AIU Membership**

The members were informed that a sum of Rs.50000/- was paid towards membership fee to become the member of the Association of Indian Universities. As per the decision communicated to us by the AIU authorities, Self Financed Universities, Private Universities and deemed to be universities are eligible for AIU membership only after five years of their establishment and must be registered under Section 2(f) of the UGC Act 1956. The efforts are being made in this regard to enroll our university as the provisional member of AIU. A letter to this effect has been sent to AIU on 28<sup>th</sup> April, 2010.

**Item No.1.7**

**Examination results of the various programmes.**

The various departments had submitted the report of the first and third semester examinations results conducted between 15<sup>th</sup> December, 2009 to 13<sup>th</sup> January, 2010. It was undoubtedly the mark of growth in all respect. The efforts of the academic staff and the students were appreciated by all the members. The results for the various courses have been put on university's website.

**Item No.1.8**

**To consider and recommended to Board of Management to start BBA.LLB (5 years Integrated) programme under the School of law w.e.f. the Academic Session 2010-2011.**

A request was made to the Bar Council of India on 23rd and 27th November, 2009 to accord approval to start 5 years Integrated BBA.LLB programme from the academic session 2010 together with the syllabi duly approved by the Academic Council. The council considered and

recommended to the Board of Management to start BBA.LLB (5 years Integrated) programme under the School of law w.e.f. the Academic Session 2010-2011.

**Item No.1.9**

**Placement of MBA students**

It was reported that various companies have been visiting the University for suitable placement of MBA students passing out in 2010. It was noted that out of 72, 36 students have been placed in the reputed companies so far. 20 students have opted self entrepreneurship. Only 22% of the total students need placements.

The members were of the opinion that consistent efforts be made for the placement of the remaining students.

**Item No. 1.10**

**Admission of the students for 2010-11**

The members were informed that consistent efforts are being made to attract large number of students across the country for admission to various courses at the university through Hoardings, Print Media, Electronic media, publicity on Air through Radio City and participation in Career Fairs.

**Item No. 1.11**

**Development/up gradation of library(s) and labs**

The members were informed that keeping in view the requirements of the programmes, the departmental libraries and labs have been developed and upgraded as per the requirements of the Statutory Councils to cater to the needs of the students and faculty.
