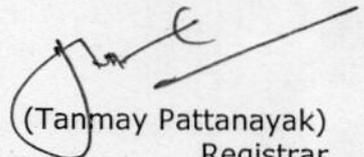

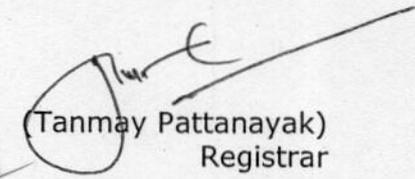

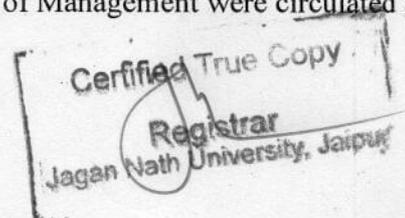
At the outset the Chairman extended warm welcome to all the members.

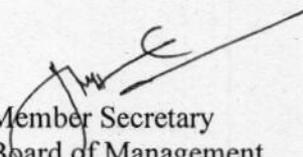
